The YPs will be expected to contribute to the Coalition's research and knowledge management offerings including undertaking landscape analysis and scoping studies, collating and disseminating insights from CDRI's programmatic activities in the form of knowledge products such as case studies, learning notes and technical notes and research publications etc. The YPs will be given additional responsibilities and duties as per the requirements of CDRI.
