**Request for Quotation for Supply of new and Buy-Back of old IT Equipment**

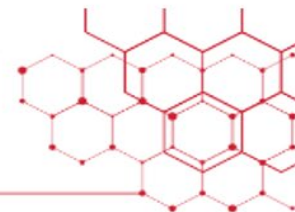
CDRI, which is an International Organization ("hereinafter referred to as "IO") *vide* gazette notification dated 11 January 2024 issued by the Government of India and published on 2 February 2024. CDRI is a multi-stakeholder global partnership of national governments, UN agencies and programs, multilateral development banks and financing mechanisms, the private sector, and knowledge institutions that aim to promote the resilience of new and existing infrastructure systems to climate and disaster risks in support of sustainable development.

1. Coalition for Disaster Resilient Infrastructure (CDRI) invites quotations from Authorized Dealers/ Distributors/ Suppliers for the **Supply of new and Buy-Back of old IT Equipment** as per the configuration/ specifications mentioned in **Annexure-II (a) and Annexure-II (b)**.
2. The bidder is expected to examine all instructions, forms, terms, and specifications in this RFQ document. Failure to furnish all information required by the RFQ document or submission of a quotation not substantially responsive to the RFQ document will be at the bidder's risk and may result in the rejection of its quotation.
3. Bidders are required to send their bid with all relevant documents as specified in **Annexure-I**, along with the price quotation **(Password-protected PDF file)** to [tender.projects@cdri.world](mailto:tender.projects@cdri.world) on or before **08 October 2025, up to 1400 hrs (IST)**.
4. Bids must be received not later than the date and time stipulated in the tender document. Client may, at its discretion, extend the deadline for submission of bids, in which case all rights and obligations of Client and the Bidder will be the same.
5. **Evaluation:**

CDRI will follow the **Single-Stage Two-Envelope Bidding Procedure**. Bidders are required to submit **two separate PDF files**:

- **Envelope I:** Eligibility Documents and General Information as per **Annexure I (Open PDF file)**
- **Envelope II:** Price quotations as per **Annexure III(a) and Annexure III(b) (Password-protected PDF file)**

**Note: The Price quotations PDF must be password-protected. Under no circumstances should the password be shared at the time of submission. It will be requested separately after the RFQ submission deadline has passed.**



Please note that CDRI is under no obligation to award the contract to the bidder quoting the lowest rates. The contract will be awarded to the bidder whose offer is determined to be the **lowest evaluated, substantially responsive bid**.

6. Only those bids that meet the eligibility and general requirements specified in **Annexure-I** and comply with the configuration/specifications mentioned in the RFQ document will be considered for opening and evaluation of the Price Quotations.
7. CDRI may, if required, request the **Best & Final Offer (BAFO)** before finalizing the order. The evaluation will be carried out on a cumulative basis, considering both the supply price of new IT equipment, as per **Price Quotation Annexure-III (a)**, and the buy-back price for old laptops, as per **Price Quotation Annexure-III (b)**.

**Price Quotation Evaluation Formula:**

**Evaluated Price (EP) = Price for New IT Equipment (Annexure-III (a)) – Buyback Value of Old Laptops (Annexure-III (b))**

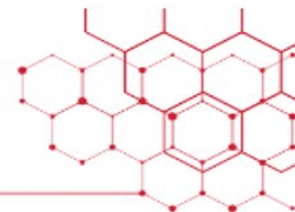
The bidder quoting the **lowest Evaluated Price (L1)** will be declared the successful bidder for the **supply of new IT equipment and simultaneous buy-back of old IT equipment**, subject to adherence to configuration/specifications in **Annexure-II (a)** and other terms and conditions mentioned in the RFQ document.

8. The buy-back rate of old IT equipment must be quoted separately. Bidders are encouraged to visit the **CDRI office during office hours (10:00 a.m. to 5:00 p.m. IST)** to inspect the laptops intended for buy-back.
9. CDRI will issue a Purchase Order for the supply of items to the successful bidder. The successful bidder must supply the items within **10 working days** from the issuance of the Purchase Order. CDRI reserves the right to cancel the order in case of a delay exceeding **10 days** from the scheduled delivery date.

11. **Liquidated Damages:** The ordered items, complete in all aspects, are required to be delivered within the period stipulated, failing which liquidated damages of 0.07% per day for the delayed goods,



subject to a maximum of 10% of the total order value, may be deducted from the final bill of the supplier.

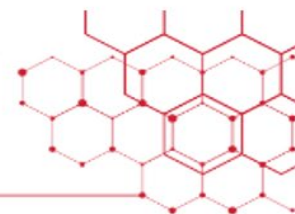
12. **Inspection:** Inspection shall be carried out by CDRI after arrival of the materials, and the decision of CDRI in this regard shall be final.
13. Conditional offers will not be accepted.
14. **Any kind of advance or part payment will not be released.**
15. 100% payment will be released within 30 days after satisfactory acceptance of materials on submission of the Tax/ GST invoice. The invoice should be duly certified by the user department or any other official of CDRI authorized for this purpose, towards satisfactory acceptance of materials from the vendor.
16. At any time before the due date of submission of quotation, CDRI may, for any reason, whether at its own initiative or in response to clarifications requested by bidders, modify the RFQ document by way of issue of Addendum/Corrigendum/Clarifications. Any Addendum/Corrigendum/Clarifications thus issued shall be shared with all bidders by email and shall be binding on them and shall form part of the RFQ document.
17. CDRI, at its discretion, may change the quantity/ quality/ parameters/ upgrade the criteria/ drop any item (s) or part thereof at any stage. In case of any dispute, the decision of CDRI shall be final and does not bind itself to accept the lowest quote.
18. CDRI reserves the right to accept or reject any or all the quotations in part or in full without assigning any reason, and does not bind itself to accept the lowest quotation.
19. **Validity of Quotation:** The quotation must remain valid and open for acceptance for a period of **60 days** from the date of opening of the quotation.
20. The successful bidder shall not sublet the work/ contract or transfer the work/ contract to any other agency or person in any manner.
21. Any act on the part of the bidder to influence anybody in CDRI is liable to rejection of his/her quotation.
22. **Dispute Resolution:** In the event of any dispute or differences arising under this agreement, the decision of CDRI shall be final and binding on both parties.
